# LETTER FROM THE PRESIDENT & EXECUTIVE DIRECTOR

2011 has proven to be another busy and productive year for Abilities Network as we continue to prioritize and accomplish our goals by maximizing our allocated resources.

We continue to receive funds from the State of Maryland and raise funds from private donors through events and grant proposals to various foundations and corporations. This year we were successful in adding several new grantors for our program support and new corporate and individual sponsors for our special events. Our Walkabout Abilities took place in September and raised more than \$62,000. DeOFest, a third party event, raised \$11,900 for our Emergency Seizure Medication Fund. In addition to our fundraising events, Abilities Network added two new social events for our individuals and families. A Bowling Social in April and an Aberdeen Ironbirds Night in June were incredibly popular. Feedback from both events was extremely positive and we look forward to additional events like this next year.

Abilities Network continues to make strides in the area of marketing and communications. The Abilities Network Newsletter, Network News, was mailed out twice, in the spring and fall, to over 8,000 individuals on our mailing list. E-newsletters and alerts about our trainings, events, resources, and other useful information were sent throughout the year to over 4,000 e-mail addresses on our e-mail list. Our Annual Awards Breakfast in May recognized our partners, sponsors, and supporters.


Abilities Network debuted an exciting and much needed service this year — Move Management Services. Move Management Services is a fee for service program, which includes one-on-one support to help people navigate through the complicated process of relocating and downsizing. We are marketing our Move Management Services primarily to seniors and people with disabilities.

Autism Services began offering Adult Life Planning (ALP) Services this year after approval from the Department of Health and Mental Hygiene and the Maryland State Department of Education. These services are available to individuals on the Autism Spectrum who are transitioning from school to adult services. Abilities Network expanded Community and Employment Partners Services to the Eastern Shore this year. After connecting with key funders and referral agencies, we are now providing support to individuals in Worcester, Wicomico, and Somerset counties.


Epilepsy Services continues to work with Morgan State University to provide epilepsy awareness and education programs to the African American community. One of the program's highlights this year was our participation in Morgan's Homecoming Parade. Through this event we distributed epilepsy awareness materials to over 1,000 individuals. Once again, we coordinated the bi-annual Epilepsy Symposium in October at the Harbor Court Hotel. Over 100 medical professionals were in attendance. Abilities Network's Healthy Families Program assisted forty families in accessing quality care for their children and helped families socialize and support each other by hosting four social events. New training was the focus this year with our Project ACT program. For the second year, our staff presented a daylong conference to 110 child care professionals at the National Institute of Health's Child Care Center. Project ACT also hosted a successful conference, "Literacy Begins in the Heart", for child care professionals in our Training Institute in September.

As evidenced above, Abilities Network continues to grow and find more opportunities to provide quality services to our individuals. We could not provide these services without your help. We thank you for your support and look forward to working with all of you in 2012 *to challenge the community to acknowledge the value and equality of people of all abilities.*

Ciara, also known as CC, began meeting with her Adult Life Planner through Abilities Network Autism Services when she was 18. Initially she would only communicate non-verbally with Abilities Network staff and only spoke when prompted by her mother. When she walked into a room, her head was always down and she was not comfortable making eye contact. CC had a very small circle of people in her life to support her, but she had a big dream of one day operating her own business.

Together, CC and her Adult Life Planner developed a Life Plan and identified goals to help CC transition from school into adulthood. CC's love for popcorn became the topic of many discussions prompting her and her team to identify ways to turn that fascination into a business. CC slowly began to build her confidence, which increased her ability to talk with people. Very soon she started to sell popcorn at birthday parties and other places in the community.

With the help of CC's family and her Adult Life Planner, she is now in the process of developing a business plan and a marketing strategy to sell her popcorn. Ciara has purchased her own commercial style popcorn maker and has set off as an entrepreneur. Each box of popcorn is labeled, "Poppin' 4 CC – UR Awesome", reflecting her enthusiastic approach to her goals. Her positive attitude, support from Abilities Network, family, and friends will make her passion for popcorn an employment opportunity and her dream a reality.

- In fiscal year 2011, Autism Services provided intensive support to 44 families.
- In November 2010, Autism Services conducted a Parent Satisfaction Survey and, on average, parent ratings indicated a high satisfaction level across all three areas assessed: Behavioral Support Counselors, Team Coordinator/Family Trainer's, and Program Services.
- In fiscal year 2011, Adult Life Planning Services provided 125 hours of service to families throughout the state of Maryland.

## COMMUNITY & EMPLOYMENT PARTNERS

In the spring of 2010, Jamaal began receiving Supported Employment services through Community and Employment Partners. Jamaal was receiving services from another agency, but did not find the success for which he was looking. Jamaal, for years, wanted to work for GameStop, and was ready to make that dream a reality.

Jamaal and his team at Abilities Network worked tirelessly; first building relationships with all local GameStop stores. Jamaal would stop by each one regularly to learn more about the company and the merchandise. In order to prepare for a possible interview, Jamaal and his team created and practiced mock scenarios he may encounter as a GameStop employee, creating a unique way to demonstrate his passion for video games to store managers. His dedication, friendly personality, hard work, and sense of humor finally impressed one local manager so much that he created a job just for Jamaal.

Now responsible for providing excellent customer service, greeting each customer, assisting with recommendations and purchases, Jamaal is proud to be the face of his local GameStop.

- Community and Employment Partners provided comprehensive support to 770 individuals in fiscal year 2011.
- Community and Employment Partners began providing services to individuals on the Eastern Shore. We began the process of meeting with key funders and referral agencies to reach out to people with disabilities and their families in Worcester, Wicomico, and Somerset Counties.
- The Employment Specialist position is now filled in each office/region. The Employment Specialist staff have been trained to specifically create relationships with businesses in the community to develop more employment opportunities for the individuals we serve.







Since the age of 6 months, Ian has lived with seizures. He has tried many different medications, but unfortunately none of them were able to give Ian complete control of his seizures. Ian had seizures in the mall, the pool, and even at school; there did not seem to be a place that Ian had not experienced a seizure. Although Ian's family had done a great job in dealing with his seizures, they needed additional support, especially at school. Ian's teachers were aware of his epilepsy, but were not comfortable talking to his classmates about his seizures.

Ian's mom found Abilities Network Epilepsy Services while researching epilepsy on the internet. An Epilepsy Services staff member came out to Ian's school and provided training for the school personnel and educational puppet shows for Ian's classmates to teach them about seizures and how to deal with them. After reading a book entitled, "Taking Seizures to School", Ian was able to understand his seizures and how to talk about them with others. Epilepsy Services was even there to help Ian's family assist with preparation for his Individualized Education Program.

Since that time, Ian and his family have become true advocates for epilepsy awareness. At the age of 7, Ian represented Epilepsy Services at the Kids Speak Up event in Washington DC. This event brings children with epilepsy and their families, from all over the country to present their message of support for epilepsy awareness to Congress. This year, Ian will return to Washington to continue to promote congressional support of epilepsy programs.

"I can't tell you how much these people and this program have helped us throughout the years. They have helped us to realize that we are advocates and that we need to help others to understand". – *Patricia (Ian's Mother)*

- In October 2010, Epilepsy Services held its biannual medical symposium at the Harbor Court Hotel in Baltimore City, where over 100 medical professionals were in attendance.
- In March 2011, Epilepsy Services sponsored Michael, a 16 year old with epilepsy, to be the Kids Speak Up representative. Michael and his father accompanied Epilepsy Services staff to the Kids Speak Up conference in Washington DC where Michael had the opportunity to share his story with Senator Cardin and legislative aides of other Maryland Representatives.
- In April 2011, Epilepsy Services held a conference for parents of children with epilepsy. 75 people were in attendance at this event.

## HEALTHY FAMILIES

Charvel began receiving services from Healthy Families Baltimore County in August 2006. At the time of enrolling, Charvel had already given birth to her daughter, Savior. Charvel also reported a lack of support in her life and having limited information on the expectations of infant development. Charvel also expressed a desire to provide an enriched environment for her daughter.

Charvel continues to be one of the biggest advocates for the Healthy Families Program. Together with her Family Support Worker, she has worked on many of her Individual Family Support Plan (IFSP) goals. One of Charvel's goals from the IFSP was to increase her support systems. Although Charvel and Savior's father are no longer together, he continues to maintain a relationship with his daughter. Charvel has also cultivated healthy relationships with two other people in her life, her mother and her father. Most recently, Charvel and her fiancé were eager to marry and with the support of Abilities Network staff, Charvel was able to begin pre-marital classes.

Charvel has made great accomplishments while in the program. She has maintained her home and employment, expanded her support systems, and supported Savior's development in every way. She has always been motivated but contends that without the support of Healthy Families, she would not have had the information that she implements daily to ensure that Savior grows and develops in a healthy way.

- During fiscal year 2011, Healthy Families hosted four parent groups: "Learning Through Literacy", "Holidays Around the World", "Taking Care of Me", and "Family Fun Day".
- 100% of the families that completed Participant Satisfaction Surveys reported being "highly satisfied" with the services they received. This is a family quote from the fiscal year 2011 survey: "I love this program. My family is better off because of everything I have been taught."
- 90% of babies born to mothers enrolled in the program gave birth to babies with a healthy birth weight (5.5lbs or more).





Steven was four years old when he was referred to Project ACT by Towson Presbyterian, his preschool program at the time. Steven had difficulty interacting with his peers and participating in teacher planned activities, such as circle time.

Project ACT worked with Steven's teachers to boost his social skills by adding social stories about appropriate social interactions and facilitating appropriate play between him and his peers. Project ACT also provided suggestions to help Steven become more involved in circle time. With the support provided to the classroom, Steven began to interact positively with his peers. Project ACT also helped Steven's parents advocate for their son at Individual Education Program (IEP) meetings to ensure that Steven received all of the services to which he was entitled. Steven was moved to a more appropriate placement within the public schools and has shown improvements in many areas.

- In September 2010, Project ACT held its annual daylong conference entitled, "Literacy Begins in the Heart", which included breakout sessions, vendors, and a keynote address. Evaluation forms indicated that 100% of the participants rated the conference excellent or good.
- In fall 2010, Columbia Academy hired Project ACT staff to present two daylong training conferences to participants. In addition, Columbia Academy hired Project ACT to present two daylong training conferences to their staff of approximately 60 people.
- The Project ACT staff served over 3,900 individuals through the Special Needs grant, funded through the Maryland State Department of Education in fiscal year 2011.



## SENIOR SERVICES

Mrs. Plotkin had lived in her home for 46 years. Her home became the extended family's storage space for all sorts of items, from her children's yearbooks to unused cars since both of her children had moved out of the house and her husband had passed away. Mrs. Plotkin was overwhelmed. She could no longer climb the stairs, maintain the yard, or take care of the house. She didn't know what to do about all of the stored items and her daughter didn't know where to begin to assist her mother.

Together, Mrs. Plotkin and her daughter called Move Management Services for help. With the help of Move Management Services, Abilities Network helped her to sort through her things so that she could decide what to move into her new senior housing apartment. Staff helped her plan furniture placement for her new home, and created an implementation timeline to share with the entire family. As soon as an apartment in her chosen community was available we packed the things she decided to move, coordinated movers, unpacked, helped her settle into her new home, and coordinated the clean out of her former home. As a result of these services, both Mrs. Plotkin and her daughter report a decrease in stress, and an increase in hope for the future.

After the move, Mrs. Plotkin's daughter wrote, "My mother felt very comfortable from the very beginning of the process with Move Management Services staff in her home. My mother is an 80 year old independent woman, and I believe her participation in this move made her feel empowered that even at her age, a positive change can take place."

- Our newest initiative, Move Management Services, completed 3 successful moves and helped 1 client sort through their belongings, creating a clutter-free and simpler living environment.
- Evaluation from the 3 moves indicated that the services and staff provided friendly, efficient support leading toward a less stressful and more successful move.
- Senior Services provided 5 Senior Speaker Series to over a 100 people, which included a range of educational topics related to the health and well being of seniors. Some topics included, "Your Move Made Easy", and "Retirement Housing Options".

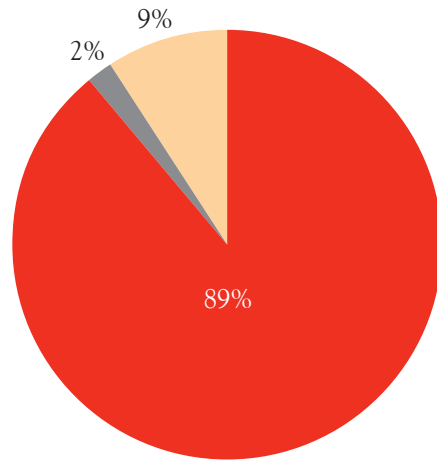

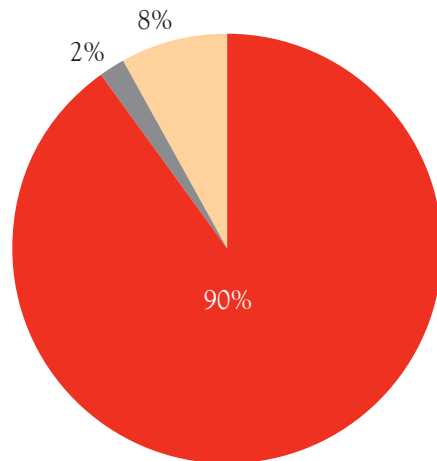
REVENUES
